


#### Hawk





These poems are quietly perceptive, unflinching: "There is no small grief.../for all are/ interconnected. One touch / sends tremors through our core / like the fly in the web / that wakes the spider at its center." Nevertheless, there's significant courage here with grace notes of buoyancy as readers are reawakened to "joy in bird song along the power lines / and between the tunes / on the radio, / the interstices / of thoughts / no one thinks about."



When Cowley died, he was the most famous poet in England. His popularity continued throughout the eighteenth century. Yet Cowley has virtually disappeared from the canon today, even from metaphysical poetry collections, although it was Cowley who occasioned Samuel Johnson's famous definition of metaphysical poetry. This book considers the circumstances behind Cowley's falling out of the canon and what he might offer future generations of readers discovering his poetry anew.




Reading Samuel Johnson examines how the eighteenth-century author, lexicographer, and wit, Samuel Johnson was later read and represented by writers between 1750 to 1970. The writers range from James Boswell and Jane Austen to Lord Byron and Samuel Beckett. The book focuses as much on these later writers as on Johnson himself. It also examines how Johnson sought to understand himself, and how later writers responded to or ignored Johnson's own self-understanding. This is the first detailed historical analysis of the way that later writers engaged with Samuel Johnson over an extended timeframe (of over 200 years).

Smollett after 300 Years offers a collection of essays on one of the great literary figures of the eighteenth century: the Scottish writer, Tobias Smollett (1721–1771). Drawing together the work of an international group of scholars, with a variety of critical approaches, the book examines aspects of Smollett's life, writing and reputation on the occasion of the three-hundredth anniversary of his birth.


Smollett is perhaps best known today as a novelist. However, he also worked tirelessly as a translator, historian, critic and editor. Whilst this book gives space to Smollett's innovations in writing fiction (described, variously, as malapropic, metaleptic, avuncular and periodical), it also draws on his wider work, situating it in the intellectual and visual culture of the book trade, traditions of domestic and humoral medicine, the politics of the Anglo-Scottish Union and projects to write a national history.

### Faking It: Victorian Documentary Novels

by Ellen Stockstill

Faking It analyzes Victorian novels that present themselves as non-fiction works. These documentary novels contain supposedly authentic transcriptions of letters, diary entries, memoirs, travelogues, witness testimonies, newspaper clippings, and other documentary evidence that purportedly verify a narrative's claims of truth. Narrated entirely through artificial documents, these books are "fake" works of non-fiction.

In a period of literary history generally considered the era of the great realist novel, we might find it surprising that many novelists chose these forms for their work—especially when we recognize and grapple with the constraints they place on the writer. These constraints, however, also afford a variety of effects both aesthetic and rhetorical. Many critics have considered documentary novels a lower art form than realist novels—less advanced in their depiction of real life and real people.




Each of the three major sections of the book is organized according to the authorial personae each author adopted in their creative and scholarly work.



the best in current Eliot scholarship. In addition, the *Annual* publishes shorter research notes, book reviews, and a comprehensive bibliography of Eliot-related publications.







### **International Yeats Studies**


